We also hereby dedicate to public use easements for public utilities, under, on or over those certain strips of land lying between the rear and/or side lines of lots and the dashed lines each designated as "P.U.E." (Public Utility Easement), such easements to be kept open and free from structures of any kind except public utility structures, lawn sprinkler systems and appurtenances thereto and lawful fences.

We further dedicate easements for wire clearance purposes only over those certain areas delineated and designated as "W.C.E." (Wire Clearance Easement) to be limited to buildings and structures and appurtenances thereto which have a maximum height of fifteen (15) feet above the grade at the ground line of poles.

We also hereby dedicate easements for pole anchor purposes only under, on or over those certain areas delineated and designated as "A.E." (Anchor Easement)

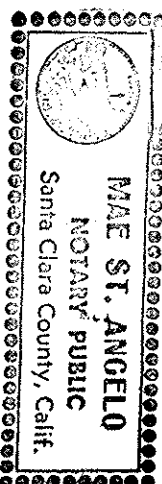
